Action Teams	Each Action Team presented a summarized version of their Charters. Each presentation raised many questions and suggestions for the Teams' work. Prevention- Dr. Levine suggested the Team add a timeline to their Actions to help with engagement and accomplishing goals; Raquel suggested the team define "prevention" to help with messaging Workforce Development- need help pushing Bill H.293; recommended to clarify roles of all CCOA members and expectations; Sarah suggested looking at the public service loan as a model (put in 10 years of service)	

Action Teams (continued)	CommSTAT- Martha questioned if the Adult LIT team was being utilized; who else is providing service supports; Ken Schatz what can DCF be doing differently; suggestion to have one Action team present during each meeting; expand triage team to non-MAT services; 4 police departments have joined the Team; identifying the most needy people that law enforcement decides based on: risks, police involvement and services needed. Treatment Access and Recovery Supports- Steve Leffler suggested we redefine the problem to just get people into treatment and provide immediate dosing-60% efficacy; Jackie suggested non-banker's hours; bring the doctor to people in need; when people walk in the door start treatment that day; Martha will review the UVMMC Grant application for the "Navigator" position; Exec Committee will approve the 2 Action Team grant applications
